These must be submitted no later than <b>April 3, 2020 at 4:00 p.m.</b> See filing and submission instructions in the first paragraph of this section. Any candidate not submitting a qualification statement before the deadline will be considered to have declined to file a statement.</p>
April 7, 2020 (Tue.)	A drawing of names to determine the order of appearance of the candidates' names upon the ballots will be held at 9:00 a.m. by the Office of the City Clerk – Election Division, located at 555 Ramirez Street, Space 300, Los Angeles, CA 90012. <p>April 27, 2020 (Mon.)</p>	<p>A ballot containing the names of the <u>Active Participant LACERS Representative</u> candidates, voting instructions, and qualification statements will be mailed to the home address of each current participant in the Plan who is also an active member of LACERS.</p> <p>A ballot containing the names of the <u>Active Participant LAFPP Representative</u> candidates, voting instructions, and qualification statements will be mailed to the home address of each current participant in the Plan who is also an active member of LAFPP.</p> <p><b>The Office of the City Clerk – Election Division is closed to the public until further notice as a precautionary measure to help slow the spread of the novel Coronavirus (COVID-19).</b> Members may set up an appointment with the Office of the City Clerk – Election Division by calling (213) 978-0440 for the following matters by <b>May 15, 2020</b>:</p> <ul style="list-style-type: none"> <li>- Hand deliver a completed ballot</li> <li>- Obtain a replacement ballot for damaged, spoiled, or lost/non-received ballots, upon filing an Affidavit of Loss/Non-Receipt</li> </ul>
<p>May 8 (Fri.) – May 15, 2020 (Fri.)</p>	<p>New eligible members, having become eligible within thirty (30) days of an election, who wish to vote must obtain a certificate verifying their eligibility to vote by contacting Mindy Lam at (213) 978-1644 or via email at <a href="mailto:mindy.lam@lacity.org">mindy.lam@lacity.org</a> or Anna Ancheta at (213) 978-1629 or via email at <a href="mailto:anna.ancheta@lacity.org">anna.ancheta@lacity.org</a>. Members may present the certificate to the Office of the City Clerk – Election Division to receive a ballot by calling (213) 978-0440 to make an appointment.</p>
<p><b>May 15, 2020 (Fri.) ELECTION DAY</b></p>	<p>The Deferred Compensation Plan shall send the Office of the City Clerk – Election Division a certified list of those who are no longer eligible to vote.</p>
<p>May 19, 2020 (Tue.)</p>	<p>Ballots will be tallied and counted at the Office of the City Clerk – Election Division starting at 9:00 a.m. Candidates may each designate two (2) observers by calling (213) 978-0440 by <b>May 12, 2020</b>.</p>
<p>May 22, 2020 (Fri.)</p>	<p>Deadline to submit any written protests to the Office of the City Clerk – Election Division by 5:00 p.m. by calling (213) 978-0440 to set an appointment.</p>
<p>May 29, 2020 (Fri.)</p>	<p>The Office of the City Clerk – Election Division will certify the results to the Board of Deferred Compensation Administration within fourteen (14) calendar days after the election. The <u>Active Participant LACERS Representative</u> candidate and the <u>Active Participant LAFPP Representative</u> candidate that receives a plurality of all votes cast in their respective elections will be declared elected.</p>
