April 1, 2021 (Thu.)	The deadline for filing and submitting candidate materials will be <b>April 1, 2021 at 4:00 p.m.</b> , to the DCP office either by email or in-person by appointment. 	As part of the candidate materials, candidates are invited to submit a statement of qualifications for office, not to exceed 250 words in length. Any words beyond the 250 word limit will not be printed. The statement of qualifications for office must be submitted no later than <b>April 1, 2021 at 4:00 p.m.</b> See filing and submission instructions in the first paragraph of this section. Any candidate not submitting a statement of qualifications for office before the deadline will be considered to have declined to file a statement.

May 20, 2021 (Thu.)	Deadline to submit any written protests to the Office of the City Clerk – Election Division by 5:00 p.m. by emailing Clerk.ElectionAdmin@lacity.org.
May 27, 2021 (Thu.)	The Active Participant WPERP Representative candidate and the Retired and Separated Participant Representative candidate that receives a plurality of all votes cast in their respective elections will be declared elected. The Office of the City Clerk – Election Division will certify the results to the Board of Deferred Compensation Administration within fourteen (14) calendar days after the election.
